

Information on Spring 2024 cross registration

- **Georgetown University**

GU-Q will start accepting cross registration forms for Spring 2024 from November 26 to December 7, 2023 at 3:00pm. The Spring 2024 schedule of classes can be found at <https://schedule.georgetown.edu/>. Select Spring 2024 then select all “Subjects” (follow instructions on page) then go down to block “Part of Term” and select SFS-Qatar. Students should email the digitally signed and approved cross registration form with a copy of the passport to the [Associate Registrar at GU-Q](#). Spring 2024 semester classes begin on January 7, 2024. Students wishing to take an ARABxxx or FRENxxx course MUST take a language placement test – no exceptions. Students should contact GU-Q about the placement test timing.

- **Northwestern University**

NU-Q will start accepting cross registration forms for Spring 2024 semester from November 26 to December 14, 2023 at 12:00pm. Spring 2024 semester classes begin on January 7, 2024. The forms should be complete with a copy of passport and send to studentrecords@qatar.northwestern.edu with the attachments in a single email. Incomplete forms will be returned to the students with a copy to the home registrar. Will accept forms only in courses with vacant seats, will inform the students and the home registrar that the form will not be processed any further. Any changes to the submitted cross-registration form will require a re-submission in a new form from the student with all the approvals. Choose only from courses indicated as “Open to Cross Registration” on the timetable.

- **Texas A & M University**

TAMU-Q will start accepting cross registration application forms for Spring 2024 semester from November 19 to December 14, 2023 at 4:00pm. Spring 2024 semester classes begin on January 7, 2024. The schedule of classes offered can be viewed [here](#) beginning on or around November 19, 2023. Please remember to select “Spring 2024 – Qatar” from the drop-down menu. To apply for cross-registration, you must:

- Complete the [cross-registration online application](#).
- Complete the [Education City cross-registration request form](#).
- Email the digitally signed and approved cross-registration request form and a copy of a valid passport to records@qatar.tamu.edu.

- **Virginia Commonwealth University**

VCU-Q will start accepting cross registration forms for Spring 2024 semester from November 19 to December 7, 2023 at 3:00pm. Completed Cross Registration forms, including requisite electronic approval signatures, must be submitted to the Office of Records and Registration (Department of Enrollment and Registration Services) by email to the [Senior Registration Officer](#) at VCUarts Qatar. Cross Registration forms which are not completed in full, missing requisite signatures, or missing the passport copy will not be accepted or processed. Please find Spring 2024 VCU-Q Schedule [here](#). Please check the column “Open to Cross Registration” on the Course Schedule. Only courses marked with “Yes” in this column are open to Cross Registration. Spring 2024 semester classes begin on January 9, 2024.

- **Weill Cornell Medical College**
